



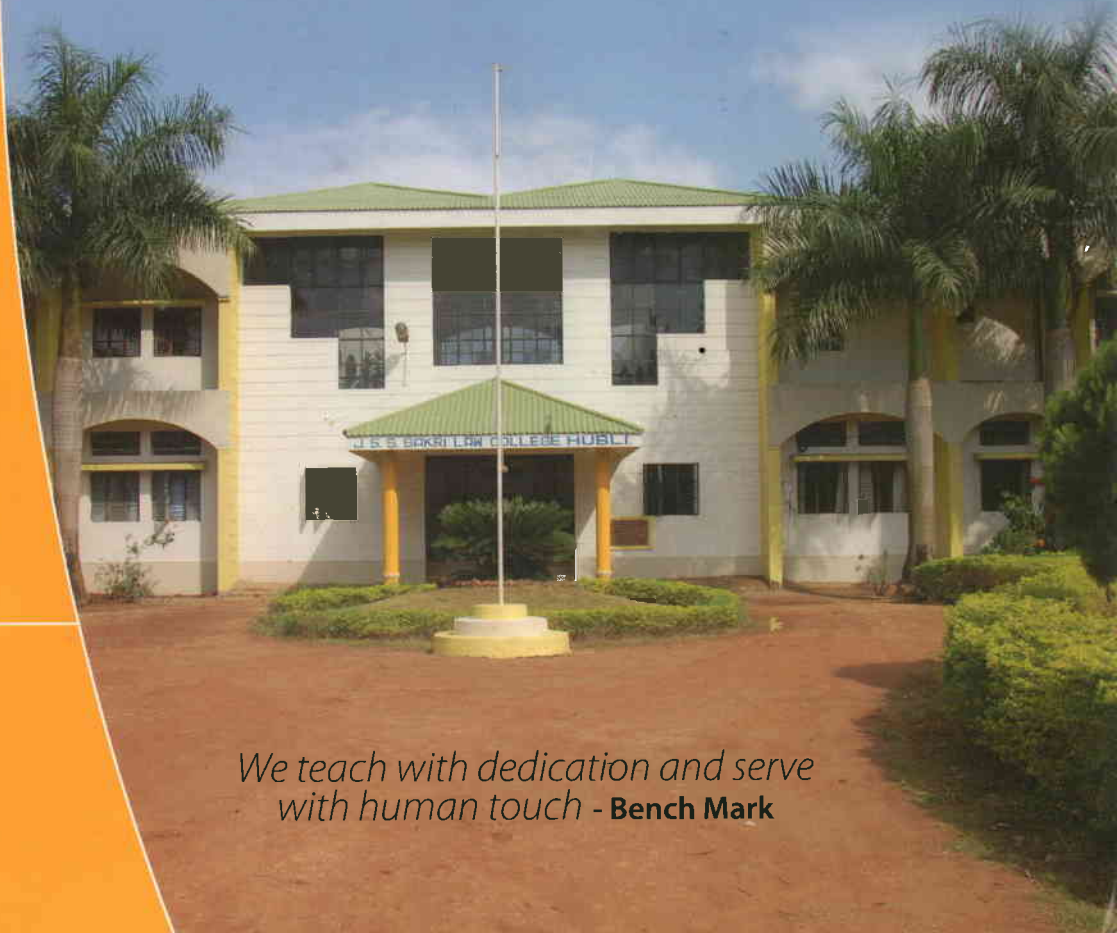

LL.B. DEGREE COURSE :

The J.S.S's Sakri Law College provides instruction to the Three Year Law Course as approved by the Bar Council of India, New Delhi, leading to degree of LL.B. after passing which a candidate can straightaway start practicing in a Court of Law. The College maintains high standards of teaching. Class work, tutorials, and periodicals tests are conducted on regular basis to provide the student a thorough grounding in the profession. The college also has a Legal – Aid Unit (which involves the students also) to provide legal and para – legal services.

The college believes in encouraging the students to come out with their own talent so that their hidden potential comes to limelight. We have dedicated teachers on our roll who gives personal attention to the students.

ELIGIBILITY CRITERIA FOR ADMISSION

(a) An applicant who has graduated in any discipline of knowledge from a University established by an Act of Parliament or by a State Legislature or an equivalent national institution recognized as a Deemed to be University or Foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for three year degree course in law leading to the conferment of LL.B. Degree on successful completion of the regular programme conducted under Karnataka State Law University, Hubli.

(b) Minimum percentage of marks in qualifying examination shall not be below 45% (44.5% and above shall be treated as 45%) of total marks in case of general

category applicants and 40% of total marks in case of SC and ST applicants

(c) Maximum age for seeking admission is limited to thirty years in case of general category of applicants and to thirty five years in the case of applicants from SC, ST and other backward communities.

THE COURSE AND DURATION

(a) LL.B. Three Year Degree Course shall be of three years duration is spread over six semesters

(b) Each Academic Year shall be divided into two Semesters

(c) Each Semester shall consist of 18 weeks

(d) The papers and the syllabus as per Karnataka State Law University Guidelines.

ATTENDANCE

No student shall be permitted to appear for the end of semester examination in given course unless he / she has, to the satisfaction of the course teacher, fulfilled the course requirements and has put in not less than 70% attendance in the Course concerned.

MEDIUM OF INSTRUCTION

The medium of instruction in the LL.B. degree course shall be English. However, the examinees shall have the option to answer the question papers in the examination either in English or in Kannada.
