OBJECTIVE

To foster an approachable and responsible attitude among all stakeholders in order to maintain a positive educational environment at the institute. The college has formed Sexual Harassment prevention cell, Anti Ragging Cell, Girl Students Grievance Redressal Cell and Student Grievance Redressal Cell, to help create a healthy atmosphere that will strive toward the holistic development of all stakeholders. These committee will investigate any complaints submitted by students or staff and handle them in the most appropriate way. Anyone with a legitimate grievance may approach committee members in person. If the person is unwilling to attend in person, grievances can be sent in writing in the suggestion box, via email, or through the link supplied by the institution on the website. RAGGING-

Ragging will be treated as a major disciplinary violation, and offenders (direct or indirect) will be treated in accordance with the guidelines notified by the Supreme Court of India on 8.5.2009 in civil appeal No. 887/2009 in "regulation on curbing the menace of ragging in higher education institutions, 2009." https://ugc.ac.in/page/Ragging-Relate=-d-Circulars.aspx.

FORMATION OF ANTI-RAGGING SQUAD.

The institution has formed a smaller organization known as the Anti-Ragging Squad, which is

nominated by the Institution's Head. It is deemed vital to maintain vigilance, oversight, and

patrolling functions and must always be mobile, aware, and active. The Anti-Ragging Squad

will be composed of various personnel of the institution and will have no outside

representation. It is also the responsibility of the Anti-Ragging Squad to conduct an on-the-

spot investigation into any cases of ragging reported to it by the institution's Head, any

member of the faculty or staff, any student, or any parent or guardian. The inquiry report will

be presented to the Anti-Ragging Committee for further action.

MONITORING MECHANISM

• Cases will be addressed swiftly upon receipt of written grievances from students/staff

within a month.

• All the committee meeting will be held at the start and end of each year, as well as

anytime a complaint is filed.

• The committee shall formally assess all personnel cases and act in accordance with

management policy.

The committee will prepare report about cases attended to and the number of pending

cases
